

## Annual Report 2019-2020

#### Dear Friends,

2020 was meant to be a celebratory year for Adolescent Counseling Services (ACS), a landmark year that marked our 45th anniversary. For the past 45 years, Adolescent Counseling Services (ACS) has fostered healing, provided critical mental health support, and empowered over 90,000 teens and their family members. ACS has continuously adapted our critical services to meet the challenges that youth face, and while we have weathered many storms, nothing could have prepared us for the intensity of the COVID-19 crisis.

I am proud to say that ACS was ready and fully operational on the day the shelter-in-place order took effect in mid-March, and our clinicians were able to maintain all of their appointments to help our clients cope with the situation and continue to work through their struggles. Not only were our clinicians able to adapt to new technology and transition to HIPAA-compliant teletherapy, but ACS staff were also proactive in finding ways to engage our clients and community virtually via remote peer support groups, outreach, education, and consultations. I am continuously in awe of our dedicated and talented staff who pulled off the near-impossible so that ACS can continue to do what we do best – save lives!

The global pandemic and shelter-in-place order have been incredibly disruptive to our daily lives. What we're seeing with our young clients is that the social isolation, anxiety about their health, and feelings of disappointment over missed milestones are leaving ALL teens at-risk for compromised mental health. We've experienced an increase in phone calls from youths and parents whose struggles are now heightened and exacerbated - depression, anxiety, hopelessness, tension at home, deeper struggles around how to cope, and increased use of substances. Teenagers need ACS more than ever before in their lifetimes! Before the crisis hit, there were scary statistics concerning our youth – one out of five suffer from a mental illness, suicide is the second leading cause of death for young people, and 75% of teens who use substances are also navigating mental health issues. All of us at ACS are concerned that these statistics will be much worse in the months ahead.

Mental health is an essential service for so many youth. They need our support, our care, our presence, and we, in turn, rely on your support to be able to be there for the adolescents who might not make it another day. Because of the support of community members like you, ACS will continue to be here, saving precious lives today, tomorrow and for the next 45 years! Thank you all!

# ON-CAMPUS COMMUNITY ADOLESCENT SUBSTANCE OUTLET COUNSELING ABUSE TREATMENT PROGRAM



Rose<sup>\*</sup> came to ACS 2 years ago through MediCal and reported having extreme anxiety talking to people, fear for unknown reasons, and nightmares. One of her fears included experiencing terror and crying whenever a door at school unexpectedly opened, because she was afraid there would be a school shooter.

Rose was 14 and a sophomore in high school, and after several sessions together, it became clear that Rose was displaying symptoms of PTSD, due to early childhood trauma of witnessing her mom become a frequent victim of domestic violence by her father, who no longer lives with them. Rose and her therapist spent time exploring the connection between Rose's trauma history and PTSD symptoms, and how they related to her current social phobia. They worked on building up her self-esteem and establishing therapy as a safe space for Rose to be herself. Together, Rose and her therapist talked about Rose's passion for social justice and her ability to harness those talents to continue to empower herself to take risks, including starting a job where she had to talk to strangers, and make new friends.

Rose has grown into a feisty, brave, resilient, and mature young woman who no longer experiences active PTSD symptoms. Rose plans to attend college next year and looks forward to that new adventure and meeting new people.

ACS' life-changing services help young people develop the attitudes, personal habits, and skills they need to build healthy, happy futures. Trained care professionals offer on-campus and community counseling, substance abuse treatment, LGBTQ+ support services, and education programs.



### Top presenting issues in youth this year:



Shiloh\* is a 16 year old nonbinary, masculine of center youth. They initially connected with the Outlet program because one of the first friends they confided in about their gender identity encouraged them to attend Outlet's Trans Group in Redwood City.

Shiloh was hesitant about attending the group at first, but after attending the group and seeing their own thoughts reflected in the experiences of others, they became more comfortable in their process of self-exploration.


With the space to question, discuss, and reflect on how they fit into the world around them, Shiloh grew in self-confidence and in trust of their own intuition. Shiloh has a stronger sense of self-worth because they see the inherent worth of others in their community. Shiloh is developing advocacy skills because they see the needs of their peers in their community.



With coaching and support from mentors at Outlet, Shiloh is beginning conversations about gender diversity with their school administration for the first time. The school has since reached out to Outlet to inquire about staff training and best practices for articulating their commitment to supporting LGBTQ+ youth with the school community. Shiloh is a very powerful person to advocate for the necessity of SOGIE education for school staff as a student on campus. Outlet supports the development of the next generation of compassionate leaders.


